# Tillamook Coast Visitors Association Announces More Than \$754,000 in Tourism Grant Awards

**TILLAMOOK**, **Ore.**, **05 MARCH 2025** — The Tillamook Coast Visitors Association (TCVA) has awarded \$754,313 in tourism facilities and marketing grants to local organizations, businesses, and municipalities for the 2024-25 fiscal year. These grants, funded by Tillamook County lodging tax, support infrastructure improvements and marketing initiatives that enhance tourism experiences and benefit the community.

"These grants are investments in the future of Tillamook County," said Nan Devlin, executive director of TCVA. "They not only strengthen our visitor economy but also improve the quality of life for residents by supporting local businesses, outdoor recreation, cultural experiences, and essential infrastructure projects."
